Bosnia and Herzegovina and Federation of Bosnia and Herzegovina, through the Sub-agreement with Bosnia and Herzegovina has received a Loan Agreement from the International Bank for Reconstruction and Development – IBRD towards the cost of Real Estate Registration Project, Additional financing, and intends to apply part of the funds to cover eligible payments under the Contract for Services of Cadastral scanning and indexing for digital archives - Phase 4, Contract Identification No.: BA-RERPAF-9048-BA-FBiH-NC-RFB-23-B.3.2.4. Service contract will be financed using the co-financing method: 51% from the IBRD loan and 49% from the Local Self Government funds.
2. The Federal Administration for Geodetic and Real Property Affairs now invites sealed Bids from eligible Bidders for Services of Cadastral scanning and indexing for digital archives - Phase 4.
3. Bidding will be conducted through national competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers – July 2016, Revised November 2017, August 2018 and November 2020. ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
4. The bidding document (and additional copies) may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of BAM 150. The method of payment will be by payment order. The document will be sent by email or can be collected at the FGA premises in person or by an authorized representative.

6. Bids must be delivered to the address below on or before August 10, 10:00 h local time. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on August 10, 10:00 h local time.
7. Bids shall be valid for a period of 90 days after Bid opening and must be accompanied by a Bid Securing Declaration.
8. Attention is drawn to the Procurement Regulations requiring the Borrower to disclose information on the successful bidder's beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the bidding document.
