Meeting with an aim to continue the Real Estate Registration Project activities

A meeting with an aim to continue the Real Estate Registration Project activities was held in premises of the Federal Administration for Geodetic and Real Property Affairs on 13 September 2018. Good project results so far are the result for additional financing the RERP project by the World Bank.

On the meeting participated the management of the World Bank headed by Mr. Jorge Munoz, Director of the Federal Administration for Geodetic and Real Property Affairs Mr. Željko Obradović, Head of the RERP project Implementation Unit of Federation of BiH Mr. Nedžad Pašalić, Head of the RERP project Implementation Unit of Srpska Mr. Jasenko Nedinić, Secretary of the Federal Ministry of

Justice Mrs. Ajša Softić, and Mrs. Samira Leskovac consultant for monitoring and evaluation of the Project Implementation Unit.

Past activities and project results were presented. In the Federation of BiH was harmonized 278 cadastral municipalities, 59% of territory was vectorized and 573,000 owners solved their real estate status. After the evaluation of all eight phases of RERP project it was concluded that during the implementation was realized even more activities than planned. The project beneficiary satisfaction rates were also shown, 77% of them rated the project as "excellent" and "very good". In the second phase of the project it is planned to include additional 100 cadastral municipalities.

Mr. Jorge Munoz, together with the World Bank management and representatives of Entity Administrations for Geodetic and Real Property Affairs visited Municipality of Centar and their Geodetic and Cadastral Service with the aim of inspecting the state of the harmonized cadastral municipalities. Mr. Amir Mujan, Head of the Geodetic and Cadastral Service of Municipality of Centar presented past activities of this project, the course of harmonization and an example of a cadastral plan copy. Cadastral employees have presented cadastral software and also assisted the management of the World Bank and Mr. Munoz on examples how to understand the harmonization process.
