Electronic bidding shall not be permitted. Late bids will be rejected. Bids will be opened on **April 18, 2016, 13:15 h** local time physically in the presence of the bidders' representatives who choose to attend in person.
6. Late bids will be rejected and returned unopened to the bidders.
7. Bids must be complete. Partial or incomplete bids will be rejected.
8. The contract will be awarded to the lowest evaluated qualified bidder.
